- 3. If you are doing your entries manually, you will need to fill in the top portions of the AVSA Collection Award Point Score Sheet. Give these to the entries chairman so the exhibitors can fill in the bottom. When all the information has been filled in or printed on the computer, fold up the bottom portion of each sheet and staple, tape or paperclip; and place them with the proper collection.
- 4. The SSA sheet, green certificate, and blue certificate are given to the panel of judges judging for the Standard Show Award. If there are two panels or less, all judges serve on the SSA panel. If three or more panels, the judges chair designates five judges to serve on the SSA Panel and appoints one judge to be responsible for the mathematical correctness of the SSA Point Score Sheet.
- 5. The SSA Panel will inform you if your show merits the green or blue certificate, so that you may display the appropriate certificate. If you desire to obtain the green or blue rosette, you may order direct from Rolling Ridge Rosettes by emailing <u>RollingRidgeRosettes@gmail.com</u>. <u>The SSA Panel will give you the Show Critique Sheet which will explain the score given for your show. You should retain this sheet and discuss the comments with your club members, so they will know where improvement is needed.</u>
- 6. The SSA Panel will also give you the completed SSA Sheet and the completed AVSA Collection award sheets. <u>Please email and/or mail these sheets to me as soon as possible</u>. These are used to officially record the show as an AVSA merit-judged show.
- 7. Any un-awarded AVSA Collection Award Rosettes should be retained by the sponsoring affiliate for future use.
- 8. At the completion of your show, the Affiliate Show Awards Report (found on the AVSA Shows & Judges website page) should be submitted by Show Chairs. This form is used to compile both the "And the Winners Are..." and "Tally Time" reports for the *African Violet Magazine*. If you do not have access to the internet, the reports may be completed by hand and mailed/emailed to the addresses list on the forms in this packet.
- 9. Reminder Again: At the completion of your show, the SSA Point Score Sheet and Collection Score Sheets must be returned to the Show Schedule Approver to ensure your show is recorded as an AVSA judged show.
