

### **Report of the President**

### Annual Report Office of the President Mary Corondan

It has been an eventful nine months serving as AVSA president. A new Marketing Committee Chair, Chris Brooks, was appointed and has made fantastic strides. A membership drive was begun in September 2023 that will continue through December of 2024. The Virtual Circle was launched and has had two Zoom meetings. The 2025 AVSA Convention was lined up for Kansas City, and *Growing to Show* is being revised by the Publications Committee with Sandy Skalski as Chair.

The graph below shows the total AVSA members from September of 2013 through December of 2023. At this point, the membership count seems to be stabilizing. The next challenge is to raise the total number of members to approach the 2013 level. This will require teamwork and dedication. The Membership Committee, in conjunction with Marketing, will be launching some promotions this year to bring this dream into reality. One of these will be an appeal to affiliates to encourage 100% within their club.



Marketing Chair, Chris Brooks, has continued the *Growing Tips* emails weekly as well as the monthly *AVSA News*. He and his committee developed new culture brochures to bring the latest growing methods to the public. Roxanne Clapp created some lovely graphics to give the brochure eye appeal.

The Virtual Circle Committee has worked to present two Zoom programs to the AVSA membership. One featured Kathy Lahti with tips on "Preparing for Show", and the other was presented by the Phoenix convention chairs. This Zoom meeting had highlights of the convention presentations, tour reviews, and a discussion regarding the entries process and show rules. Everyone is looking forward with eager anticipation to this event. The next Virtual Circle Zoom meeting will be this summer.

A site centrally located in the continental United States was sought for the 2025 AVSA Convention. HelmsBriscoe recommended a hotel in Kansas City that would keep costs low. Missouri Valley African Violet Council was approached as a possible host affiliate for the convention. They accepted this position and will be partnering with the African Violet Club of Greater Kansas City and Sho-Me African Violet Club. Randy Deutsch will be Convention Chair, and Linda Hall will serve as Show Chair.

The Publications Committee has been meeting regularly to update and revise the 2008 *Growing to Show* book. There are a few sections that need major revamping and others that will need very little. The goal is to have the new edition ready to go on sale at the Kansas City AVSA Convention in 2025.

The Executive Committee meets monthly. By doing this, it is easier to keep the forward momentum going on projects. It also results in shorter meetings at national conventions and enables the Executive Committee more time to comingle with the membership at convention. Strategic planning is being addressed as time permits.

Meetings are held with Amy as often as they are needed. Keeping communication lines open with the AVSA Office is essential.

It is a pleasure and an honor to serve AVSA as president. The support of the officers, board, and staff is greatly appreciated. Together, we can move AVSA forward and prepare the organization for the future.

After serving the past ten (10) months as 1<sup>st</sup> VP, I again reflect on the leadership knowledge and experience I continue to gain, especially from working with the talented committee chairs noted in this section of this report, as well as committees from prior years. Much work was undertaken and completed as the AVSA has over the past few years, made great strides in rebranding our organization with a fresh, new look, new technologies, new membership, and a growing community of African violet enthusiasts! Our hopes are high that we will continue these successes with the hard work of all of our AVSA committees. To all Committees – please accept my sincerest gratitude for your dedication to our organization and your commitment to making your committee work positively impact who we are.

As a member of your AVSA Executive Committee, I regularly attend EC monthly and any other specially called meetings and events. With the advent of remote meeting technologies, the AVSA has made great strides in conducting regular and special Society business on a more frequent basis than just the previous Spring and Fall meetings.

The EC meets regularly with Amy Carruth, Office Manager, to keep abreast with the daily operations of the national office, to maintain healthy lines of communication, and address any requests from office staff. Amy and I usually connect weekly to keep updated on office issues. I am preparing now for my new duties as Salary Chair where I will facilitate annual AVSA employee evaluations and work performance. The Salary Committee will meet this spring to discuss, review, and process annual employee performance evaluations. I frequently travel through Beaumont and spend in-person, face-to-face time with office staff. They are quick to have me help out with the telephone calls while I am there! I have also stamped envelopes and even helped with some of the daily office work!

Your EC continues to work on the strategic planning process as a major foundation upon which the AVSA will achieve its critical mission. This is noteworthy, as outcomes from this process will provide AVSA with a more focused direction and approach for the future. Input from all Committees continues to be instrumental in how this future direction is put into play. This is an excellent opportunity for all Committees and volunteers to make a difference in the future of AVSA. The EC continues to work to "fine-tune" committee governance by consolidating committees and streamlining AVSA business and committee processes, roles, and responsibilities. Consolidation of committees to better meet the business needs of AVSA is crucial to maintain efficiencies, as well as improve allocation of our limited and much-valued volunteer resources. AVSA is like many nonprofit organizations today, working to maintain healthy membership numbers as we provide valuable resources and information to our growing communities. I continue to encourage all of you to do your part and help your Vice Presidents in this process through your continued input and feedback, especially with recommendations of where improved efficiencies can be implemented and realized.

I continue to work hard to enhance and improve - wherever possible - communications between all the 1<sup>st</sup> VP committees, especially when committees overlap. It is important for all AVSA committees to communicate and collaborate whenever possible, as this is a wonderful way to enhance the effectiveness of our limited volunteer resources to achieve all the work we do. From the beginning of my term, my 1<sup>st</sup> VP committees have had availability of my personal upgraded Zoom account at no cost, allowing for meetings longer than 45 minutes. Some committees have taken advantage of this and those that have not should consider this offer as a way to keep your committees communicating.

With planning almost completed for the upcoming 2024 Phoenix National Convention, I continue to be guardedly optimistic about in-person attendance. Post-pandemic issues, our struggling economy, and competing hobby interests continue to be the driving force behind attendance and participation decisions. The AVSA should focus on increasing public outreach and education to growing communities to encourage membership and convention attendance growth.

I actively participate in the Lone Star African Violet Council activities as Past President and Commercial Vendor. Although attendance was still low compared to years pre-pandemic, the show was filled with beautiful entries. Post-pandemic issues as well as shrinking wallets continue to impact attendance and sales at all events. I encourage all to continue to attend – in person - local, state council, and national events, as these are the foundations of keeping interest going in our AV growing communities.

I currently serve as Secretary/Treasurer/Parliamentarian of the Central Texas Judges Council and as President of the Heart of Texas African Violet Society, one of Texas' newest affiliates, specializing in public outreach and education using remote technologies.

I continue to present numerous AV-related presentations across the country (via zoom and local sites), as well as provide my services as a Senior Judge for shows and displays Visitors to my website <u>www.ghviolets.com</u> can find downloadable *free* information files about AVs, including access to my personal blog – "AV Chatterbox." I offer my services *gratis* and ask that any donations be made to AVSA in lieu of speaker fees. I am passionate about public outreach and education about AVs, and this is my way of giving back to AVSA. I will continue this as long as I am able to travel and can afford it.

I continue my education as an AVSA Senior Judge by auditing and attending judging schools whenever and wherever possible. Being able to separate the classroom component into online education has been extremely beneficial to me as well as other Executive Board members who are also continuing their education. Kudos to the Show and Judges Committee for developing/evolving this improved curriculum for judging. Your judges really needed this!

I recently assumed the role of AVSA Archivist when Janet Riemer retired. Janet did a wonderful job managing the archives throughout the years. Her work was beyond excellent and is evident today in our archives. A new project/initiative is in planning now to use current technologies to build on the archive framework setup by Janet and digitize, store, and archive current paper artifacts. The AVSA archive room is filled with so much AVSA history and I enjoy every opportunity possible to connect with all the physical artifacts stored there.

Membership growth remains relatively stagnant. Amy continues to report new memberships are still happening, but AVSA continues to lose about as many members as are gained during the year. Data from the recent Member Survey provided us with informative and valuable data that is driving several new initiatives that are underway. AV Magazine articles were written to inform membership of the initiatives and to encourage new member interest. The Membership Campaign is well underway, offering discounts and benefits to everyone, especially those who are renewing memberships. I encourage each of you to reach out to the public as a way to garner interest and encourage new membership.

The Membership Committee continues to work with the EC to increase membership and with other committee chairs to prompt AVSA membership.

- 1. Next step is to increase AVSA membership via our affiliates. This is a challenging task since it would involve deploying our directors to interact heavily with the AVSA affiliates they oversee. The Membership Committee is open to any ideas from the EC they may have.
- 2. Working on the dues increase sandwich board selection.
- 3. Committee continuously works with the "Virtual Circle" programs.
- 4. Working with the Advertising committee to support the AVSA membership drive and formulate a new way to

#### promote it.

AVSA is truly blessed with Sophia Bennett, our highly competent Editor. The AVM continues to advance to a more sophisticated document under her leadership. Transition to the new print shop with the newly formatted and designed AVM has saved the AVSA a substantial amount of money. Kudos to Sophia and Mary Corondan who worked hard to make this transition happen with minimal issues.

The AVM Advertising Committee is commended for their proactive hard work generating a 7.9% increase in ad revenue, bringing three (3) new commercial memberships on board. Even with several commercials having to address, even temporarily closing and/or ceasing advertising due to a serious INSV issue, Advertising was able to achieve noticeable and successful growth over the past year. The committee works closely with the AVSA Office to ensure ad notices are sent out in a timely manner, as well as to follow up on commercials who are delinquent in payment for advertising. Most commendable is how proactive this committee is working with the Commercial Committee to network and encourage improvements in communications between committees and commercials.

The Fundraising Committee continues with their annual Booster campaigns. There is still work to be done educating membership about the many AVSA funds, their importance, how they operate, and their part in how the organization functions financially. The Fundraising Committee should continue working on the goal of educating the membership on the purpose of the various funds and how they can be involved in the giving process.

The Publications Committee will continue working with the AVM Best Articles Contest. The committee also acts as lead in the "Growing to Show" Book Update project/initiative. This is a collaborative effort between the Publications and Library Committees to revise this book, originally written and published by author Paula Bartholomew. The last publish date was 2008 and the time has come to revise key areas, especially lighting (LED); diseases and pathogens; fertilizers; and other key topics where common practices, techniques, and technologies have evolved.

The Tally Time Committee was busy this year keeping up with collecting and reporting on affiliate results. Information was aggregated and posted on the AVSA website. There were reported problems with reporting this year due to reporting process and technology changes, as well as issues obtaining affiliate reports. The chair is working closely with the TechWeb Committee to report and hopefully resolve these issues through process streamlining and technology solutions.

Since September 2019, I have functioned as the AVSA Business Continuity/Disaster Recovery (BC/DR) Coordinator and offer my continued support in this role as long as needed. The AVSA Policy and Procedures Manual "Business Continuity/Disaster Recovery Policy" section was officially updated in 2023, expanding the previous "Hurricane Policy" into a more in-depth and comprehensive policy to benefit AVSA in the event of a disaster event.

As I continue into my second year as 1<sup>st</sup> VP, I will continue transitioning into this new role and to further grow my skills, knowledge, and experience as an EC member. I again thank the EC, EB, and the AVSA membership for the opportunity to serve in this capacity. It continues to be a humbling experience and will most certainly be memorable. Please continue to go forth and be advocates for our AVSA organization. Encourage new membership and participate in more public outreach and education.

Chris Brooks has been a dynamo with regard to publishing the weekly growing tips, proposing new activities and initiatives, navigating the African violet hat contest, and brainstorming promotional ideas to further AVSA's interest and increase membership.

### **Report of the Third Vice President**

### Annual Report Office of the Third Vice President Richard Craft

Third Vice President activities since June, 2023

My goal as Third Vice President is a lofty goal. AVSA came into existence over 75 years ago and comments have been made that our organization is still operating in the 20<sup>th</sup> century (ideas, thought processes, technology, committees, etc.) The median age of members is...old. Can a nonprofit organization with an objective "to stimulate a widespread interest in the propagation and culture of African violets," be relevant today?

The advent of the internet allowed people with computers to search for answers to their African violet growing needs. Then social media became mainstream which allowed groups to gather together, in an open forum, to discuss the latest advances in growing everything from African violets to zinnias.

Today, hand-held mobile devices connect to the same internet and allow people to ask questions about their ailing plants while they are traveling by bus or car or even plane. Answers to their questions are returned in minutes instead of days or weeks later. But is all that advice being thrown about beneficial to your specific growing conditions?

I had a new club member go on Facebook and asked a question about watering her plants. A guy answered insisting that only rainwater should be used to water her African violets.

Dude! She lives in Las Vegas, Nevada surrounded by desert. If she waited long enough to collect enough rainwater at her house, her plants would be a crispy mess. Uninformed advice like this will kill your collection.

Then there are the self-professed experts who parrot information they have heard in order to make themselves appear smart...and some couldn't keep African violets alive if their life depended on it.

There's lots of forums to gather information online to become a better grower, but there is also information which has to be carefully discerned before applying it to your growing regimen.

What's my lofty goal? To close the gap by "gathering and publishing reliable, practical information..." about "...the culture and propagation of the African violet, and other information of interest to the members." Read on to see what incremental steps I've been taking to close the gap between AVSA 1.0 and AVSA 2.0.

I serve on the following committees:

#### Advertising Committee (Chair)

I am in charge of all the advertising within the pages of the African Violet Magazine (AVM). My responsibilities include servicing all the commercial members' ad accounts and invoicing them throughout the year. I created an area on the AVSA website to display their business logos and link to their online businesses. Nothing new there that wasn't done in the early days of the internet.

However, Growing Tips, a weekly email newsletter, features those same business logos, which are exposed to a larger audience. Chris Brooks, our new Marketing Chair, has created some interesting, innovative content each week for the Growing Tips. The newsletter is also distributed to Facebook and Instagram which have generated many discussions in the African violet groups. Closing the gap by leveraging social media.

#### Library Committee (Vice Chair)

For this committee, the busiest time of year for me is at Convention where I do showroom photography and videotape presentations. I am in the process of locating enough server space to host recent convention photography and recorded presentations.

#### TechWeb Committee (Web Designer)

Some of my responsibilities include:

- Improve website performance, redesign webpages, add new content
- Posting the digital version of the African Violet Magazine (AVM) on the website in a book-like format for members to read online. There is also a link to download the AVM, so they can read it at their leisure.
- We have recently signed up for a TechSoup account which helps nonprofit organizations such as AVSA, providing discounted hardware, software, and technology solutions. I've been exploring the opportunities we can take advantage of.
- I provide tech support for AVSA's latest addition for members only, the Virtual Circle. I set up the landing page where visitors can learn about the next upcoming event and register online. The registration process is linked to our iMIS membership management website that verifies that registrants are AVSA members.
- I am working with Dr. Jeff Smith to develop an online form to register African violets (see below for detailed info)

Closing the gap by using today's technological tools to create a more appealing, accessible website.

In addition to serving on the committees above, I have enjoyed participating in the following events.

**Heart of Texas African Violet Society** (McDade, Texas) I am a charter member of this virtual club which has been in existence for nearly two years. I moderate the first 90 minutes of the Zoom session, often doing educational presentations on various topics.

**Copper State African Violet Club** (Phoenix, Arizona) Last year I helped set up and tear down their spring Show & Sale. I brought plants to exhibit in their show and served on a panel helping to judge the show. Additional plants were brought to sell and benefit their club.

**Lone Star African Violet Council** (Kerrville, Texas) At their fall convention, I helped some of the vendors setup their sales areas and served on a panel judging the gesneriads. It was an honor to do my presentation, "The ABCs of N-P-K."

**Mid-Atlantic African Violet Society** (Gettysburg, Pennsylvania) The AVSA Executive Committee traveled to the east coast to hold our fall meeting. Three of our officers did presentations for the convention attendees.

Initially, their original venue in Baltimore closed its doors a month before the start of their fall convention. They were fortunate to locate a venue in time for their convention. However, in a series of unfortunate events, the original show room became a freezer due to an irreparable heating system. In the middle of placement, exhibit plants were moved across the street to the hotel lobby. Vendors had to setup in the hallway. The first banquet was moved into a room so

small that people were eating elbow to elbow. Despite horrendous circumstances, MAAVS managed to put on a great show.

Closing the gap by participating in local and state activities and sharing my growing knowledge.

As Third Vice President I am assigned a number of committees to oversee. My goal was to challenge each Chair to make small improvements to their committees—do things a little different than was done by their predecessors—in order to move AVSA forward. I declare that each Chair successfully met that goal.

#### Plant Registration and Master Plant List Committee (Dr. Jeff Smith)

It has been a pleasure working with Jeff since he moved into the Chair role to lead this important committee. In the beginning, we both had to learn the specific procedures that had previously been managed by the talented Joe Bruns. That allowed Jeff to start organizing those procedures into a workflow he could manage his way.

I gave Jeff two challenges to tackle. He went above and beyond and collected so much data, that I'm now behind in attempting to sort them out.

- 1. The first was to research the plant registration record keeping system of other plant societies in order to develop one that AVSA can ultimately implement. This is a work in progress.
- 2. The other challenge was to consider alternatives to First Class, the electronic version of the Master Varieties List. This is in a preliminary stage and has been tabled for the time being.

One other challenge to improve Jeff's committee falls on me. It involves developing an online form to register new plants. Currently there is a PDF that the hybridizer has to download and fill out. The completed form with pictures needs to be returned by scanning and emailing the files. The alternative is to stuff the paperwork into an envelope and send via snail mail. This is so ancient that it has received quite a bit of nasty comments on social media.

This is a gap that not only needs to closed, but eliminated altogether. There are website tools that can be used to bring much needed reform to streamline the processes involved in plant registration.

#### Violet Preservation (Mary Thompson)

Mary has continued with marginal success matching some people with their wanted violets. She continues with her AVM column, "Violets Most Wanted List."

#### Affiliate Committee (Mary Thompson)

This is another situation where a committee member has stepped up into the Chair position to take over leadership. Mary had the unenviable task of contacting all the affiliate clubs asking them to update their contact info on the AVSA website. Problem was that a lot of clubs had outdated contact information, and some had even disbanded. Mary discusses this in the January 2024 AVM.

Are African violet clubs a thing of the past? Depends on who you ask. There are the aging clubs which have devolved into nothing more than social gatherings. This may work in a tight-knit community where like-minded people gather and idle chatter suits them fine. Yet, for these types of clubs, attracting new members becomes difficult.

Some clubs have a robust teaching schedule and have monthly presentations done by club members or guests invited to make presentations via Zoom. The Zoom phenomenon grew out of popularity during the years 2020-2022, otherwise known as the pandemic years. It continues to this day, some clubs even adapting a hybrid style mixing in-person meetings

and Zoom meetings. These types of clubs have managed to close the gap and stay relevant to their community attracting new members.

But are these clubs growing enough to replace the numbers lost when clubs disband? There is a discussion being planned at Convention this year when I meet with Steve Covolo-Hudson, Membership Chair and Chris Brooks, Marketing Chair.

Mary brought up her own challenge and pointed out that some people get totally frustrated and are intimidated trying to use the Webpage titled, "Guide for Starting a New Club." I spoke with Terri Post, AVSA Treasurer and she concurred that the content labeled "Legal Checklist" needs to be rewritten.

#### TechWeb Committee (Candace Baldwin)

Candace continues to lead this committee with the skills she learned through her previous job experience. There are many tasks associated with keeping the AVSA website running smoothly. The TechWeb team meets regularly, every 3 weeks to prioritize tasks. Special meetings may be called to meet deadlines. Recently, we've been meeting with Joe Bruns to support him in finishing updates to the Entries program.

#### Directors

Recruiting five capable Directors each year has become a challenge. A bylaw amendment will be voted on to begin a drawdown, reducing the number of Directors chosen each year. By 2027, there will only be three Directors chosen each year.

I will be developing a guideline for potential candidates to be read before they apply for a Director position. They will also receive this document or be able to read it online when they are installed at Convention. Closing the gap by empowering ambassadors to reach out to the public.

### **Report of the Treasurer and Finance Chair**

### Annual Report Office of the Treasurer and Finance Chair Terri Post

During the first four months of 2023, I compiled and prepared the financial statements for fiscal year 2022, and I also filed an extension for the 2022 Form 990 tax return. I then prepared a 2024 budget to be presented to the board.

In March, 2023, I filed the final report for the foundation that AVSA received a grant for during 2022. They require financial statements by December 31. During April, 2023, I filed for the new 2023 grant. They rejected our filing for the 2023 grant.

In September of 2023, I prepared and filed the 2022 Form 990 tax return. This return is public information and a copy can be obtained by filing a written request to the AVSA office. The return is also available for the public to view at <u>www.guidestar.org</u>. This is a website endorsed by the IRS. To recap AVSA investments:

The Life Fund is primarily invested in bonds and CDs. A few CDs were called and/or matured during 2023 and the funds from them was reinvested into municipal bonds and CDs. The approximate rate of return for the entire fund was 2.66%. AVSA also had to withdraw \$10,000 from this fund during 2023 in order to meet operating expenses.

The BERF fund has been invested in treasury bonds, CDs and a mutual fund. The BERF committee has asked to keep some of this fund liquid in order to pay out any possible scholarship as needed. The approximate rate of return for this fund during 2023 was 3.84%. Scholarships of \$2,000 were also awarded from this fund during 2023.

The Tinari Fund has also been invested mainly in CDs and bonds. The approximate rate of return for this fund was 3.14%.

The Burde Fund has been invested in bonds and some CDs. The approximate return for this fund during 2023 was 1.88%.

During the year 2023, the Hudson monies earned approximately 2.2%. It is hoped that this fund will be able to pay for future awards with earnings.

I feel that we have been able to reinvest earnings on our investments and, at year end we were able to draw on them to help us with immediate cash needs. This enables us to continue to grow and provides financial stability for the future, as was the desire of the original endowment donations.

The 2025 budget will be prepared and presented to the board for approval at the Phoenix convention.

The event was accepted and published in the 2024 edition. The listing includes information about our AVSA convention, office location, and website. The Chase's Calendar of Events is the most comprehensive reference available on holidays, special events, international days of celebration, federal and state observances, and more. This is a source for most media and publishers. I have just received the renewal notice for 2025 and will submit for the Kansas City convention.

This past year, my own affiliate, Copper State African Violet Club, was fortunate to host a show and sale in April 2023. We had a fabulous turnout! People were very excited and eager to purchase violets. We have continued to have monthly meetings with informative and interactive, hands-on programs. Copper State AVC is looking forward to hosting the 2024 AVSA Convention.

I have and will continue to promote AVSA by attending local and regional events, whenever possible.

3. The committee continuously works with the "Virtual Circle" programs.

4. The committee is working with the Advertising committee to support the AVSA membership drive and formulate a new way to promote it.

The candidates were confirmed and requested to supply their biography and a recent photograph, which would be used in the Jan-Feb-2024 issue of the African Violet Magazine (AVM).

All candidate supplied their requested materials and the column was published in the Jan-Feb-2024 issue of the AVM.

The current bylaws indicate that Directors shall be elected from the membership-at large, one (1) and no more than two (2) of whom shall be a resident of a nation other than the United States...

Our committee was unable to secure a nomination to fulfil this requirement and it is hoped that a nomination from the floor, at the AGM, will yield a satisfactory candidate to complete the proposed slate.

With the diminishing population of our membership, it has been difficult to secure willing members to serve as Directors.

As such, a proposal was drafted and submitted to the bylaws committee and then to the Executive Committee to reduce the number of Directors from 15 to 9 members, with a transition period during which the number of directors shall be 15 in 2024, 13 in 2025, 11 in 2026 and 9 in 2027 and thereafter.

Notice was given int the Jan-Feb-2024 AVM (page 23) that the proposed amendments to AVSA Bylaws, Articles IV, V and VII will be voted on at the AVSA 2024 Annual Convention in Tempe, Arizona.

At this time, there are no anticipated budgetary requirements and no funding requests have been made to the Finance Committee.

Plants Registration and Master Plant List—Dr. Jeff Smith

Dr. Smith accepted to serve as chair of this committee in May 2023. His status as the registrar for African violet cultivars has been made official with the International Society for Horticultural Science (ISHS) and he appears as the contact person on their website.

During the time from May 2023 to February 2024 a total of 33 new cultivar registrations from 10 hybridizers have been approved. An additional 2 cultivars have been "listed" in First Class but were not registered. The listing request was made by the hybridizer as these plants are chimeras and do not always reproduce true to type even by traditional reproduction methods for chimeras violating the three-generation stability requirement for registration.

The current online registration system appears to be working well. However, we would like to point out some processing procedures that may not be known to the general AVSA community. These steps are intended to provide good customer service for hybridizers with new cultivar registrations.

- 1. Messages sent to the <u>registration@avsa.org</u> address come to Dr. Smith, but an acknowledgment message is not automatically generated and sent to the sender. Dr. Smith replies to all inquiries or applications, and provides assistance with the process and checking of all required application materials. An online form will be developed by the TechWeb Committee later this year and an acknowledgement will be sent to the applicant's email address upon submittal.
- 2. Application materials are placed on a Google Drive site with each application in a different folder. The application materials are also backed up on Dr. Smith's laptop.
- 3. The Google Drive application folders are "shared" with the committee members and a tentative description is generated and discussed by the committee.
- 4. The committee has been writing more detailed descriptions than were used historically. Since the data is electronic and not printed in hard copy, costs are not as big a factor. More detailed descriptions should make plant identification easier.
- 5. The Google Drive folders can be shared with Joe Bruns for publishing in First Class and with Sophia Bennett for picture use in the African Violet Magazine.
- 6. Any questions or concerns about the application (most usually about the requested cultivar name) are sent to the applicant by Dr. Smith.
- 7. Once a description has been approved by the Committee, notifications are sent to the applicant, Joe Bruns for updates in First Class and Sophia Bennett for publishing in the African Violet Magazine.
- 8. Sharing the approval of a new cultivar with the hybridizer has proven important to their business and marketing efforts. There is a delay in the updates to First Class and publication timelines in the African Violet Magazine. Many hybridizers are marketing their new plants via Facebook or other sites.

The guidelines for the naming of new cultivars are covered in the International Code of Nomenclature for Cultivated Plants published by the International Society for Horticultural Science. The most recent publication is 2016 and is no longer

available in print. However, Dr. Smith obtained the use of a copy using his university's library loan system. He has made scans and copies of the relevant pages for future reference and referral.

One item that has been of interest is the record keeping system used by different plant societies. Dr. Smith has contacted the registrar of approximately 25 plant societies asking for information about their registration process and database. Responses have been received from approximately 12-14 groups. All responses have been forwarded to Richard Craft for consideration by the TechWeb Committee. The responses tended to fall into the following categories or groups:

- 1. Groups with small databases are using Excel
- 2. Groups with medium-sized databases have adapted other types of software.
- 3. Groups with large databases have contracted a software company for specific programs. One group estimated the cost was \$25,000.

The AVSA database for cultivars would fall into the "large" category.

One dilemma that has been identified is the storage and upkeep of the registration records. Older records are currently on cards or paper and stored in the AVSA office. Joe Bruns has previously reported that some are becoming illegible with time. Other data storage methods are microfilm, CDs (aging technology), or personal laptops. Some investigations have been made using SharePoint and OneDrive for record storage. The software used for First Class needs constant monitoring for updates. While no solutions have yet been suggested for all record storage needs, the Committee hopes that attention will be given to finding some sort of updateable electronic storage of the AVSA's cultivar records.

One question that has been raised concerns the status of sports of species plants. Are they still a species or are they a new cultivar? According to the International Code of Nomenclature for Cultivated Plants, Article 20: Naming Wild Plants Brought into Cultivation (page 23)

"20.2 Plants of a species or lower taxon brought into cultivation may not demonstrate the range of variation associated with that taxon in the wild. If an assemblage of those plants has one or more characters that make it worth distinguishing, it may be given a cultivar or Group name."

Although we have not yet received a request for registering a variegated species plant as a new cultivar, we feel that such a plant could be registered with an appropriate cultivar name. The name cannot be something like "variegated diplotricha" because the naming rules will not accept a Latin name as the cultivar name. Such a plant would also be recognized as a cultivar, not a species, and should not be exhibited in the species class of AVSA shows. Once named as a cultivar, these plants should be shown in the most appropriate cultivar class.

#### Research—Dr. Jeff Smith

The current committee membership is:

I have asked both members to continue to serve and as of this report neither has indicated a desire to leave the committee.

#### Old Business

Dr. Smith serves on the Research Committee for The Gesneriad Society, Inc. This allows him to spot potential research projects for the AVSA from the proposal submissions to The Gesneriad Society. However, the 2023 grant applications to The Gesneriad Society were all on other genera with no applications relevant to the AVSA.

One grant request was received in 2021, approved in 2022 and concluded in 2023. This proposal was from Dr. Cornelius Mulili Kyalo from the National Museums of Kenya. The title of the proposal was "The conservation of African violets (*Streptocarpus*) in the wild: population expansion and community awareness, costal Kenya". Dr. Kyalo provided the required publication on the project for the African Violet Magazine which appeared in the March/April 2023 issue.

Dr, Xingbo Wu of the University of Florida had been in communication regarding grant opportunities. The project he had in mind would have a budget of approximately \$100k. Dr. Smith explained that was beyond the means of the AVSA and that a grant budget would need to be around \$2-3k. Dr. Wu countered with a project with a budget of \$25k. Dr. Smith

explained again that the AVSA is an organization of plant hobbyists and the size of a likely research grant. Dr. Wu reluctantly responded that he might be able to do something with a budget of \$3k. Dr. Smith suggested possible projects and offered to help with supplying plant material. Dr. Wu was sent the grant application. There was a discussion that an African violet project might fit one of Dr. Wu's students. Dr. Smith also sent Dr. Wu the link for the AVSA scholarship. However, there have not been any further communications from Dr. Wu.

#### **New Business**

Dr. Smith encouraged some of his students to conduct studies in fertilizer effects on starting leaf cuttings, rooting new plantlets and regeneration of adult plants. All projects were locally sponsored by Dr. Smith and the Indiana Academy for Science, Mathematics and Humanities. Manuscripts for two projects have been sent for publication in the African Violet Magazine. Two additional manuscripts will be sent soon. Dr. Smith will present the results of these studies at the Phoenix 2024 AVSA Convention. Hopefully, these types of small-scale research projects will serve as a model for future work.

A new grant application was received on February 21, 2024 from Dr. Cornelius Kyalo of the National Museums of Kenya. The application is titled: "Rescuing the last two populations of the critically endangered *Streptocarpus ionanthus* subsp. *rupicola* from limestone mining in coastal Kenya". The application materials are submitted as additional supporting documents to this report. The Research Committee has reviewed the grant application and recommends funding. The requested amount of \$4500 is the same as the last grant awarded to Dr. Kyalo. If funding is not immediately available, discussions should be held with Dr. Kyalo for an alternative amount, or perhaps releasing funds over the next few months as they become available.

Dr. Kyalo points out in his application that other populations of this species in Kenya are now extinct due to habitat destruction. The AVSA is fortunate that plants from these areas still exist in cultivation thanks to the conservation efforts of Ms. Anne Robinson. Many of the wild species populations are under extreme threat and conservation efforts such as those proposed in Dr. Kyalo's application are critical to keeping populations of the species from extinction.


#### Shows and Judges—Mary Corondan

There were 7 judging schools offered in 2023. Fourteen students earned their student judge's certificate. There are nine new advanced judges, and ten renewed their advanced judge certificate.

The senior judge's exam was taken by 30 students. There will be 11 new master judges as of October 1, 2024. They are Karen Campbell (Nova Scotia), Valerie Despres (Nova Scotia), Kathleen Garbarino (NY), Lorraine Hilfer (OH), Susan Hill (OK), Lee Hoke (NY), Paul Hussa (MN), Penny Moore (NY), Dorothy Raymond (NY), Geneva Stagg (TN), and Carol Tjaden

(IA). The following 13 judges are retiring with Master Judge Emeritus status: Judy Carter (OK), Elaine Click (TX), Ken Froboese (TX), Dolores Gibbs (TX), JoAnne Martinez (FL), Wilma Wolverton (MO), Janet Riemer (NJ), Sandra Mims (SC), John P. Nabers (TX), Linda Neumann (OH), Barbara Pershing (IA), Catherine Thompson (IA), and John E (Jack) Wilson (FL).

There were a total of 45 shows in 2023. The SSAA award was earned by 20 shows, the SSA award was given to 9 shows, and 4 shows received neither award. No SSA score sheets were received by 12 shows. This may have been due to an issue with the entries program. Two shows were canceled. Below is a chart that shows the fluctuation in the number of shows annually since 2014.
